A. Checklist of Requirements:

2. Delete the required "Certificate of Good Manufacturing Practice (CGMP) or TUV or ISO or its equivalent for equipment only".
3. Delete the required "Training Certificate of the Technical Personnel / Service Engineer who were trained to conduct installations, preventive and corrective maintenance of the equipment. The certification must be issued by the principal or manufacturer of the equipment being offered and it must contain name of person concerned, date when training was conducted and the description or title of training.
4. A revised Checklist of Requirements will be provided to the prospective bidders.

B. Technical Specifications:

1. In page 2, replace the *One (1) Brand New Unit Photocopier* to **One (1) Unit Photocopier**.
2. In page 3 under the Other Terms and Conditions item no. 1, delete the word Brand New Unit for the Photocopier and the requirement becomes **"The Supplier shall bind itself to supply/provide the Southern Philippines Medical Center Two (2) Brand New Units of Mimeographing Machine and One (1) Unit Photocopier**.
3. In page 4 under the other Terms and Conditions item no. 3, the requirement must be **"The supplier must bind itself to service the equipment and maintain the machine on a regular or scheduled basis (at least once a month) at its own expense"**.
4. A revised Technical Specifications will be provided to the prospective bidders.

All other provision of the bidding documents which are not affected shall remain in effect.
