Supply and Delivery of Office Supplies (Re-bid)

Bid No: 2017-03-1246 (ABC No.: 2017-012 (SPMC); 2017-015 (NSC-Min))

This Bid Bulletin No. 1 is being issued as modification to the eligibility, technical and financial requirements of the above-mentioned project. The following modifications shall prevail and form an integral part of the Bid Document.

A. Checklist of Requirements

1. Financial Requirement No. 2 – to add requirement in the Financial Proposal Sheet, which includes bid prices and the bill of quantities and the applicable Price Schedules in accordance with ITB Clauses 15.1 and 15.4 (using the prescribed form). **Bidders are required to indicate the sub-total of the items offered per page of the Financial Proposal, in figures and in words**

B. Bid Data Sheet (BDS)

1. Bid Data Sheet 13.1 – to add specification of the requirement “The financial bid form shall be termed also in this bidding as the “financial proposal sheet”. The financial proposal sheet form states all the items to be procured by the procuring entity. The bidder shall fill up the forms by indicating its bid offer or bid prices, in words and in figures, on the items it will submit as bid, using the prescribed form. **Bidders are required to indicate the sub-total of the item offered per page of the Financial Proposal Sheet, in figures and in words**”.


1. Item No. 1 - BATTERY RECTANGULAR 9 VOLTS
*to reduce quantity from 337 pieces to **265 pieces**
2. Item No. 2 - CARD, PVC, 500'S
*to add particulars: CARD, PVC, **A4 size**, 500'S
3. Item No. 15 - Paper, Continuous (Prescription)
*to add particulars: Paper, **Continuous, 8.5" x 11" x 5.5", 1-ply** (Prescription)
4. Item No. 18 - PAPER, NEWSPRINT LONG, BLUE
*to add particulars: PAPER, NEWSPRINT LONG, BLUE, **ground wood**
5. Item No. 19 - PAPER, NEWSPRINT LONG, PINK
*to add particulars: PAPER, NEWSPRINT LONG, PINK, **ground wood**
6. Item No. 20 - PAPER, NEWSPRINT SHORT, PINK
*to add particulars: PAPER, NEWSPRINT SHORT, PINK, **ground wood**
7. Item No. 28 - TAPE, MASKING 1" , USABLE LENGTH 50M, STRONG ADHESIVENESS
*to change particulars to TAPE, MASKING 1", USABLE LENGTH **25 YDS**, STRONG ADHESIVENESS
*to increase from 1,000 rolls to **2,000 rolls**

8. Item No. 29 - TAPE, MASKING 2" , USABLE LENGTH 50M, STRONG ADHESIVENESS
*to change particulars to TAPE, MASKING 2", USABLE LENGTH **25 YDS,**
STRONG ADHESIVENESS
*to increase quantity from 500 rolls to **1,000 rolls**
9. Item No. 2 (NSDC-Min) - Tape, Masking 1", 50 meters
*to change particulars to Tape, Masking 1", **25 yards**
*to increase quantity from 20 to **30 pieces**

The BAC requests the Bidders to use **BLUE** colored folders for your Eligibility, Technical and Financial requirements.

All other provision of the bidding documents which are not affected shall remain in effect.
