Office Supplies (Re-bid)

Bid No. 2016-08-0327 (ABC No. 2016-020 – Southern Philippines Medical Center
and 2016-031 – Newborn Screening Center – Mindanao)

The Bid Bulletin No. 1 is being issued as modification to the eligibility and technical requirements, financial requirements and the Bid Data Sheet (BSD) of the above-mentioned project. The following modifications shall prevail and form an integral part of the Bid Document.

A. Checklist of Requirements

1. Eligibility and Technical Requirement No. 3 – to correct the requirement from “Statement of the prospective Bidder of all its ongoing and completed government and private contracts of similar project within the last three (3) years including contracts awarded but not yet started, if any, *whether similar or not similar in nature and complexity to the contract to be bid;...*”

to

Statement of **all its ongoing government and private contracts, including contracts awarded but not yet started, if any, whether similar or not similar in nature and complexity to the contract to be bid; and**

Statement identifying the **bidder's single largest completed contract similar to the contract to be bid** within the last three (3) years, except under conditions provided for in Sec. 23.5.1.3 of the IRR, within the relevant period as provided in the Bid Data Sheet.

The statement shall include, for each contract, the following:

- (iii.1) the name of the Contract;
- (iii.2) date of the Contract;
- (iii.3) kinds of goods sold;
- (iii.4) amount of Contract and value of outstanding contracts;
- (iii.5) date of delivery;
- (iii.6) end-user's acceptance certificate or official receipt(s) issued for the contract, with the following supporting documents, **Purchase Order (P.O.) or Contract Agreement with Notice of Award (NOA)**, *if completed*. If ongoing, attach *Purchase Order (P.O.) or Contract Agreement or Notice of Award (NOA)* stating the amount of the project.

*Note: For this purpose, similar contract shall refer to **Supply and Delivery of Office Supplies***

B. Financial Proposal Sheet

b.1. Southern Philippines Medical Center

1. To **delete** Item No. 1 – Board, Cork 2ft. x 3 ft. x ¼ ft. with aluminum frame
2. To **delete** Item No. 3 – Chart Cover Plastic; 9x12.5, as per sample
3. Item No. 4 – Clip, Paper, Small
 - To reduce quantity from 500 boxes to **417** boxes
4. Item No. 7 – Folder Long, Plastic w/ Slider, Thick, Asstd Colors
 - To reduce quantity from 200 pieces to **166** pieces
5. Item No. 23 – Staple Wire #35, Known Brand, Heavy Duty, Genuine add: 150 boxes
 - To **delete** “**add: 150 boxes**” from the particulars. The item will be stated as **Staple Wire #35, Known Brand, Heavy Duty, Genuine**
6. Item No. 34 – Whiteboard w/ aluminum frame 4ftx8ft
 - To reduce quantity from five (5) pieces to **two (2)** pieces

b.2. Newborn Screening Center – Mindanao

1. Item No. 8 – Clear Book, long size, black
 - To add particulars: Clear Book, long, size, black, **thick**
2. Item No. 13 – Plastic Cellophane Thick, pack, 100s, size: 6x12 for packing filterpapers in the NBS Kits
 - To add particulars: Plastic Cellophane Thick, pack, 100s, size: 6x12 for packing filterpapers in the NBS Kits (**as per sample**)

All other provisions of the bidding documents which are not affected shall remain in effect.
