This BID BULLETIN No. 2 is issued to modify or revise the *Bid Data Sheet, Special Conditions of Contract, Technical Specifications, Price Schedule* and clarify other requirements of the abovementioned project. This modification shall prevail and form an integral part of the Bidding Documents.

a. Bid Data Sheet

- Clarification on Clause 20.2 Items a & b, the submission of the a) Certified True Copy of the Valid to License to Operate from PNP SOSIA and b) Certified True Copy of the Valid Firearm Licenses and the Monthly Disposition Report (MDR) received and duly stamped by FEO and RCSU X will be during the **Post-Qualification of Bids**.
  - The Monthly Disposition Report (MDR) to be submitted will be **March 2021** only.

b. Special Conditions of Contract

- Under Clause 1 Item 1, the deletion of the phrase "Clearance of No Pending Case of Any Violation". The provision will now read as "**Certification of remittances from SSS, PAG-IBIG, and PHILHEALTH that membership contributions were remitted for the 1<sup>st</sup>, 2<sup>nd</sup>, 3<sup>rd</sup> and 4<sup>th</sup> Quarter of 2020**".
- Under Clause 1 Item 2, the deletion of the phrase "that the bidder has no pending Administrative Case for the violation of labor laws / rules and regulation within six (6) months from the opening of bids". The provision will now read as "**Clearance from the Department of Labor & Employment (DOLE)**".

c. Technical Specifications

- The Security Agency's number of years of existence will be revised from "Five (5) Years to **Three (3) Consecutive Years**" with a regular license to operate prior to the advertisement and/or posting of the Invitation to Bid.

d. Price Schedule

- Under Item D and E number of hours of duty was erroneously indicated and will be revised from Eight (8) Hours to Twelve (12) Hours. A **new Price Schedule** Form will be provided.

All other provision of the bidding documents which are not affected shall remain in effect.
