The Southern Philippines Medical Center now invites bids for the supply and delivery of the abovementioned goods. Delivery of the Goods is required 15 calendar days from receipt of the Purchase Order. Bidders should have completed, within **3 years** from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instruction to Bidders.

Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”. Bidding is open to all interested bidders, whether local or foreign, subject to the conditions for eligibility provided in the IRR of RA 9184.

Interested bidders may obtain further information from Southern Philippines Medical Center – Procurement Section and inspect the Bidding Documents at the address given below during **8:00 A.M. – 5:00 P.M. – Monday to Friday**.


A complete set of Bidding Documents may be purchased by interested bidders on **May 31, 2017** from the address provided below and upon payment of applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB in the amount stated above. It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their Bids.

The Southern Philippines Medical Center will hold a Pre-bid Conference on the abovementioned date at the SPMC BAC Conference Room, 2<sup>nd</sup> floor beside Central ICU Building, Davao City which shall be open to prospective bidders.

Bids must be duly received by the BAC Secretariat at **SPMC – Procurement Section/BAC Conference Room, 2<sup>nd</sup> floor beside the Central ICU Building, Davao City** on or before the time and date of submission of bids specified above. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in the ITB Clause 18.1 Bid Data Sheet. **Bid opening** shall be on **June 22, 2017, 9:00 A.M. at the SPMC –BAC Conference Room, 2<sup>nd</sup> floor beside the Central ICU Building, Davao City**. Bids will be opened in the presence of the bidders’ representatives who choose to attend at the address below. Late bids shall not be accepted.

The **Southern Philippines Medical Center** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 or RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
