

# Contract Agreement

THIS AGREEMENT made this 28th day of February 2014 between **SOUTHERN PHILIPPINES MEDICAL CENTER** of J.P. Laurel Avenue, Bajada, Davao City, Philippines (hereinafter called "the Entity") of the one part and **MEDICOTEK INC.** of Suite 1409 Paragon Plaza Condominium, No. 162 EDSA cor. Reliance St., Mandaluyong City, Philippines (hereinafter called "the Supplier") of the other part:

WHEREAS, the Entity invited Bids for **Procurement of Twenty (20) Units Trauma Stretcher** and has accepted the bid of the SUPPLIER with the Total Contract Price of **Six Million Four Hundred Forty Thousand Pesos (Php 6.440,000.00)** (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz.:
  - (a) the Bid Form and the Financial Proposal Sheet submitted by the Bidder;
  - (b) the Schedule of Requirements;
  - (c) the Technical Specifications;
  - (d) the General Conditions of the Contract;
  - (e) the Special Conditions of the Contract;
  - (f) the Entity's Notification of Award; and
  - (g) the Performance Bond.
3. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Contract.
4. The Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.
5. The effectivity of this contract shall be from issuance of Notice to Proceed up to the end of warranty period (two years warranty) of the equipment.








