# Contract Agreement

THIS AGREEMENT made the 28th day of February 2019 between **SOUTHERN PHILIPPINES MEDICAL CENTER** of J.P. Laurel Avenue, Davao City, Philippines (hereinafter called "the Entity") ON THE ONE PART and **HEALTHSOLUTIONS ENTERPRISES, INC.** of Unit 6E, Amber Place, No. 67 Bayani Road, Western Bicutan, Taguig City, Philippines (hereinafter called "the Supplier") ON THE OTHER PART:

WHEREAS, the Entity has invited interested bidders to Bid for certain goods and ancillary services, viz., **Supply and Delivery of ECG Electrodes with Provision of One (1) Brand New Electro-cardiograph Machine** and has accepted the Bid of the Supplier to supply those goods and services in the sum of **Twenty Nine Pesos (Php 29.00) Cost per use** (hereinafter called "the Contract Price");

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents shall be deemed to form, be read and construed as part of this Agreement, viz.:
  - (a) the Supplier's Bid, including the Technical and Financial Proposals, and all other documents/statements submitted (e.g. bidder's response to clarifications on the bid), including corrections to the bid resulting from the Procuring Entity's bid evaluation;
  - (b) the Schedule of Requirements;
  - (c) the Technical Specifications;
  - (d) the General Conditions of Contract;
  - (e) the Special Conditions of Contract;
  - (f) the Performance Security; and
  - (g) the Entity's Notice of Award.
3. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to provide the goods, equipment and services and to remedy defects therein in case of malfunction, in conformity in all respects with the provisions of the Contract;
4. The Entity hereby covenants to pay the Supplier in consideration of the provision of the goods, equipment and services and the remedying of defects therein, the Contract Price on Cost per use as agreed or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract;
5. The Supplier shall provide additional number of Electro-cardiograph Machine and consumables whenever there's a need for such supplemental machines without the necessity of executing another Contract Agreement. Payment or charges is in accordance with the Contract Agreement's provisions on the Cost Per Use basis;
6. The effectivity of this contract shall be from issuance of Notice to Proceed up to the end of the one-year contract period which is May 10, 2020. Two (2) days after receipt of the Notice to Proceed, the delivery of the machine and availability of the thermal paper which

will be completed in 60 calendar days. These 60 days used during delivery and procurement of thermal paper shall be considered as an extension or addition to the one (1) year term of contract;


7. This Agreement may not be modified or altered except by written instrument duly executed by both parties.

This Agreement constitutes the entire agreement between the parties with respect to the subject matter hereof and supersedes all prior and contemporaneous agreements or communications. Performance hereunder shall be governed by the laws of the Republic of the Philippines. Venue of any case for breach of this agreement shall be in Davao City only.

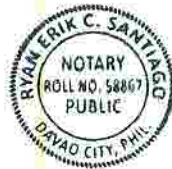
